

About the Conference

On June 27, 2018, CIP invites you to participate in a CIP hosted webinar series featuring speakers from various backgrounds and expertise, aimed at educating and inspiring discussion around Indigenous planning topics.

Many goals of Canada's Indigenous communities – First Nation, Inuit, Métis, and Urban Aboriginal peoples – intersect with planning concerns. These goals include preserving language and culture, building governance and planning systems, investing in community health and wellness, practicing sustainable resource management, establishing self-reliant economies, developing sustainable food and energy systems, and improving community housing and infrastructure.

In 2003, CIP established an Indigenous Community Planning Committee (ICPC), which has worked to help build national capacity and support for Indigenous planning and community development. CIP is committed to implementing the Truth and Reconciliation Commission's calls to action, by identifying opportunities that professional planners can both lead and support. CIP is currently developing policies on Planning and Reconciliation, which advocate for effective collaboration with Indigenous communities, organizations, and individuals from Canada and around the world.
